6. I shall moreover defend, indemnify, and hold harmless NAMDAF and its Board for and against any action or claim brought by any person as a result of any injury, illness, damage or loss.

8. Underage players wishing to participate in a higher league agree to and acknowledge that:
 - a. The reasons for the exemption were discussed with my clubs President or coach and that the implications were explained to me in full.
 - b. The risks of this consent are fully understood and that neither my Club, Provincial, or National bodies will be held accountable for any injury that might be incurred regardless of the division I/he/she will be participating in.
